saw S-2- meet up with Alexander. said Alexander purchased the baby diapers and the coffee filters, but that Alexander never made any attempt to pay for the 4 boxes of the concealed cold medication in his waistband. said after Alexander purchased the other items, that he and cited the front of the store.

4 [redacted] ran towards them and called them "mother fuckers!" She then attempted to hit [redacted] in the face with
